



The University of Oregon has recovered a collection of salvaged materials from Hayward Field that can be used to benefit the local community. The university is seeking proposals from the public to use these salvaged materials in creative ways. The university wants to celebrate Hayward Field's legacy by using these materials to positively impact the community for years to come.

An advisory committee comprised of a cross-section of stakeholders with an interest in Hayward Field, historic preservation, and Oregon track and field will lead this process for gathering and reviewing Proposals and, ultimately, making recommendations for use of these materials. The advisory committee includes representatives from the following organizations:

4. If a proposal is selected and the proposer is not able to finish the project by the identified timeframe, the proposer is responsible for working with BRING to make salvaged materials available to the community.
